

1. Janine Marie Oliver, DVM ("Dr. Oliver") of McLeansville, N.C., has been licensed by this Board as a veterinarian since May 15, 2008, holding license number 6410.
2. The Board has jurisdiction of Dr. Oliver and of the subject matter of this Consent Order.
3. The Board's Committee on Investigations No. 1 (the "Committee") recommends that the Board approve this Consent Order as an appropriate means to resolve the 16 complaints

received in 2020 against Dr. Oliver: 2020025-1; 2020030-1; 2020036-1 (combined with 2020050-1); 2020038-1; 2020040-1; 2020045-1; 2020047-1; 2020049-1; 2020051-1; 2020053-1; 2020055-1; 2020061-1; 2020062-1; 2020063-1; 2020065-1 and 2020074-1 [collectively referred to as “the complaints.”]

4. The complaints were assigned to the Committee for investigation pursuant to Board Rule 21 NCAC 66.0601.

5. Dr. Oliver denies the material allegations of each complaint.

6. As of this date the Committee has reported to the Board its decisions and recommendations on four of the complaints. The investigations with respect to the remaining complaints have not been completed and no decisions have been reached.

7. At the September 10, 2020 Board meeting the Committee reported with respect to 2020025-1, filed by Ms. Shannon Bowen, that its decision was a letter of reprimand [Board Rule 21 NCAC 66.0601(h)] and a recommendation of a civil monetary penalty of \$2,000.00. The Board gave preliminary approval to the Committee’s decision and recommendation, subject to the letter of reprimand being prepared, approved by Committee and mailed.

8. At the September 30, 2020 Board meeting Committee reported decisions and recommendations in three other complaints: in 2020038-1, filed by Ms. Tonya L. Aahner-Mejia, a letter of reprimand and a recommendation of a civil monetary penalty of \$1,500.00; in 2020040-1, filed by Ms. Wannetta White; a letter of reprimand and a recommendation of a civil monetary penalty of \$3,000.00; and in 2020053-1, filed by of Ms. Emilia Rizzolla, a letter of caution [Board Rule 21 NCAC 66.0601(j)]. The Board gave preliminary approval to these decisions and the civil monetary penalties, subject to the letters of reprimand and the letter of caution being drafted, approved by the Committee and mailed.

9. Dr. Oliver agrees to accept the letters of reprimand and the letter of caution in the complaints identified in paragraphs 7 and 8 above, but she denies the material allegations in the complaints.

10. Pursuant to this Consent Order Dr. Oliver will permanently surrender her veterinary license, 6410, previously issued to her by the Board, and as more specifically set forth below, she will not hereafter seek to be licensed as a veterinarian in North Carolina, nor registered as a veterinary technician, nor practice veterinary medicine in this State.

11. The Board agrees to withdraw the civil monetary penalty assessments in complaints 2020025-1, 2020038-1, and 2020040-1; and the Board agrees to dismiss the remaining pending complaints: 2020030-1; 2020036-1 (combined with 2020050-1); 2020045-1; 2020047-1; 2020049-1; 2020051-1; 2020055-1; 2020061-1; 2020062-1; 2020063-1; 2020065-1 and 2020074-1.

12. Dr. Oliver has signed this Consent Order and agrees to its terms, but her agreement is not an admission of wrongdoing, which she has expressly denied, and her agreement is made to avoid time and expense of further proceedings.

13. This Consent Order terminates all licensure and professional relationships between the Board and Dr. Oliver.

Based upon the foregoing Findings of Fact, the Board makes the following Conclusions of Law.

CONCLUSIONS OF LAW

1. The Board has jurisdiction of Dr. Oliver and of the subject matter of this Consent Order.
2. This Consent Order is entered by the Board under the authority granted it by Article 11, Chapter 90 of the N.C. General Statutes and the administrative rules adopted thereunder.
3. The terms of the Consent and Waiver of Janine Marie Oliver, DVM, below are part of the covenants and agreements on which this Consent Order is based.
4. Dr. Oliver's permanent voluntary surrender of her license does not constitute a disciplinary action.
5. This Consent Order resolves the above-captioned complaints against Dr. Oliver and terminates all licensure and professional relationships between the Board and her.

CONSENT AND WAIVER OF JANINE MARIE OLIVER, DVM

Janine Marie Oliver, DVM, an adult under no disability, by signing this Consent Order, stipulates and agrees that: she has read its contents; she has had the opportunity to consult with an attorney about its contents prior to her signing it; she does not contest it and she waives her right to contest the Findings of Fact, Conclusions of Law and the Order in any subsequent proceeding before the Board, or before a hearing panel of the Board, or in a Court of competent jurisdiction; she consents to the Board attorney, the Executive Director of the Board, and the members of Committee on Investigations No. 1 discussing the Consent Order with the other members of the Board or a hearing panel of the Board prior to its being entered by the Board; she consents to the entry of this Order either by the Board or by a hearing panel of the Board, as applicable, to be signed by the Board President, or by another Board member, or by the Executive Director of the

Board; she understands the Consent Order's effect upon the license previously issued to her by the Board and its effect upon her ability to apply for a license as a veterinarian, or for a temporary permit or for registration as a registered veterinary technician or to practice veterinary medicine in North Carolina as defined by the N.C. Veterinary Practice Act; she waives the right to a contested case hearing or other hearing on the facts or legal conclusions that are the bases of this Consent Order; she agrees to comply with the terms of this Consent Order; and she expressly waives her right to judicial review of this Consent Order under provisions of N.C.G.S. Chapter 150B, or the N.C. Veterinary Practice Act, and Board Rules, or other applicable law.

Based upon the foregoing Findings of Fact and Conclusions of Law, and with Dr. Oliver's express consent and waiver, the Board enters the following Order.

ORDER

1. This Consent Order resolves the complaints against Dr. Oliver identified in the Findings of Fact, above, and it terminates all licensure and professional relationships between the Board and Dr. Oliver.

2. Upon the approval of this Consent Order by the Board, Dr. Oliver will permanently surrender to the Board veterinary license Certificate No. 6410 issued to her; and upon the surrender of her license she will not thereafter seek to renew the license or to become licensed in North Carolina as a veterinarian; nor register as a veterinary technician; nor apply for a temporary permit to practice veterinary medicine; nor seek to own all or part of a veterinary practice in North Carolina if future laws permit such ownership by persons not licensed to practice veterinary medicine; nor offer to practice or practice veterinary medicine in North Carolina as the term

“practice of veterinary medicine” is defined in N.C.G.S. § 90-181(6) and Board Rules; and except with respect to medical records of her former patients, she will not communicate nor offer or communicate information regarding any former patient or animal when the communication constitutes the “practice of veterinary medicine.”

3. The Board modifies its decisions of September 10, 2020 and September 30, 2020 and withdraws the assessments of civil monetary penalties in complaints 2020025-1, 2020038-1 and 2020040-1, respectively, but the approvals of the decisions of the letters of reprimand on those complaints and the letter of caution in complaint 2020053-1 remain in effect, subject to the letters being prepared, approved by the Committee and mailed to Dr. Oliver.

4. Dr. Oliver accepts the letters of reprimand and the letter of caution.

5. The Board dismisses the remaining pending complaints: 2020030-1; 2020036-1 (combined with 2020050-1); 2020045-1; 2020047-1; 2020049-1; 2020051-1; 2020055-1; 2020061-1; 2020062-1; 2020063-1; 2020065-1 and 2020074-1.

6. The Board retains jurisdiction of this matter until all requirements of this Consent Order have been completed and complied with by Dr. Oliver.


